Petitioners are welcome to request that an item of work is carried out by a specific Heraldic Artist. While the Lyon Office will do its best to accommodate such requests no guarantee is given. Agreement to such a request is not binding on the Lyon Office, allocation of cases being affected by workload, the availability of Heraldic Artists and other factors. It should be noted that agreement to a specific Heraldic Artist carrying out work does not result in the work being allocated more quickly. The item of work will be allocated to the specified Heraldic Artist in order of listing.

Bank transfer details are available upon request and will be issued along with the draft text and individualised note of specific Dues, Fees and Charges. Cheques should be made payable to "*The Scottish Government*".

A note of additional embellishments is available upon request and will be issued along with the draft text and individualised note of specific Dues, Fees and Charges. The individualised note will then be revised in accordance with any additional embellishments requested.
